162.4 PLANNING:

Applications

11/07567/FUL – 3 Chapel Row, Wheeler End -householder application for construction of single storey rear extension (alternative scheme to 10/07242/FUL). We object to this application and suggest that a site visit is undertaken before a decision is taken. Our objections are as follows:

The extension as shown in the drawings is over the access to nos 1 and 2 Chapel Row and contrary to the statement made, no discussions have taken place with the owner of nos 1 and 2 about re routing the access. We cannot envisage how waste and recycling bins can be brought to the front of the property without bringing them through the house if the current access is blocked. No alternative access has been shown.

The width of the proposed extension is from boundary to boundary and in actual fact extends beyond the party wall boundary - all gutters will be on the adjoining properties land and all associated maintenance and possibly construction would have to be undertaken from that land

We would question the accuracy of the drawings regarding the property boundary between no 3 and no 2.

Should the extension be granted permission we feel that as the property is in the Conservation Area the materials of construction should be in keeping with the property i.e. brick and flint. 11/07525/FUL – 20 Princes Street, Piddington – construction of two storey extension – no objections.
